Policy on Loading Zones Area Privilege Permits

Existing Regulations

- A. Loading Zones (area privileges) are created under Article III, Division 3 of Section 94 of the Municipal Code.
- B. Application procedure (94-162). A person or business desiring a loading zone may apply at the office of the City Engineer. The completed application is to be returned to the office of the City Engineer and accompanied by the footage fee. All area privileges expire on December 31. The normal procedure for approval is submission of the application, and approval by the City Engineer.
- C. Costs (94-163). Applicants are charged for materials (signs, pipe, block, brackets, labor and vehicles) required to install Loading Zone signs. In addition to this installation fee, there is a footage fee (see "B" above) assessed to all applicants except: schools, churches, hospitals and charitable institutions devoted to or which furnish free services to disabled persons.

The footage fee is paid at time of application; the installation charge is made after installation.
- D. Hours of use (94-165). The code has established hours for Loading Zones as 9 AM to 6 PM, except Sunday and Holidays.
- E. Types of Zones (94-161) are "Limited" and "Unlimited." The "Unlimited" zone has signs that are in place at all times, the "Limited" zone is in effect only during those times when signs are set up (this type of zone normally has signs which are attached to portable stands).

Points of Clarification

A. Location

The zone will normally be established abutting or as close as practical to the applicants' place of business.

B. Size

Typical size for a loading zone is 22' (feet).

Policy on Loading Zones (cont'd)
(Area Privilege Permits)

C. Use of Zone

- Delivery/pick-up of people (church, medical related).
- Delivery/Pick-up of material (grocery stores, print shops, flower shops, manufacturers, etc.).

D. Parking in a Loading Zone is permitted only temporarily and while engaged in loading and unloading activity. A vehicle parked for more than 15 minutes in a Loading Zone with no loading activity is subject to being cited.

E. Limitations of Use

A loading zone, established on a public street, is available for use by any business, individual, and for any purpose; its use is not limited to vehicles associated with the applicant.

F. The cost of a loading zone cannot be avoided by requesting a "No Parking Zone" instead of a "Loading Zone."

G. Reasons for Denial or Revocation

Requests for Loading Zones may be denied due to:

- Type of business.
- The zone effect on traffic flow, etc.
- Non-payment of charges.
- Use as a parking area by the business or customers.
- Change in type of occupancy in the buildings originally associated with the zone, etc.
